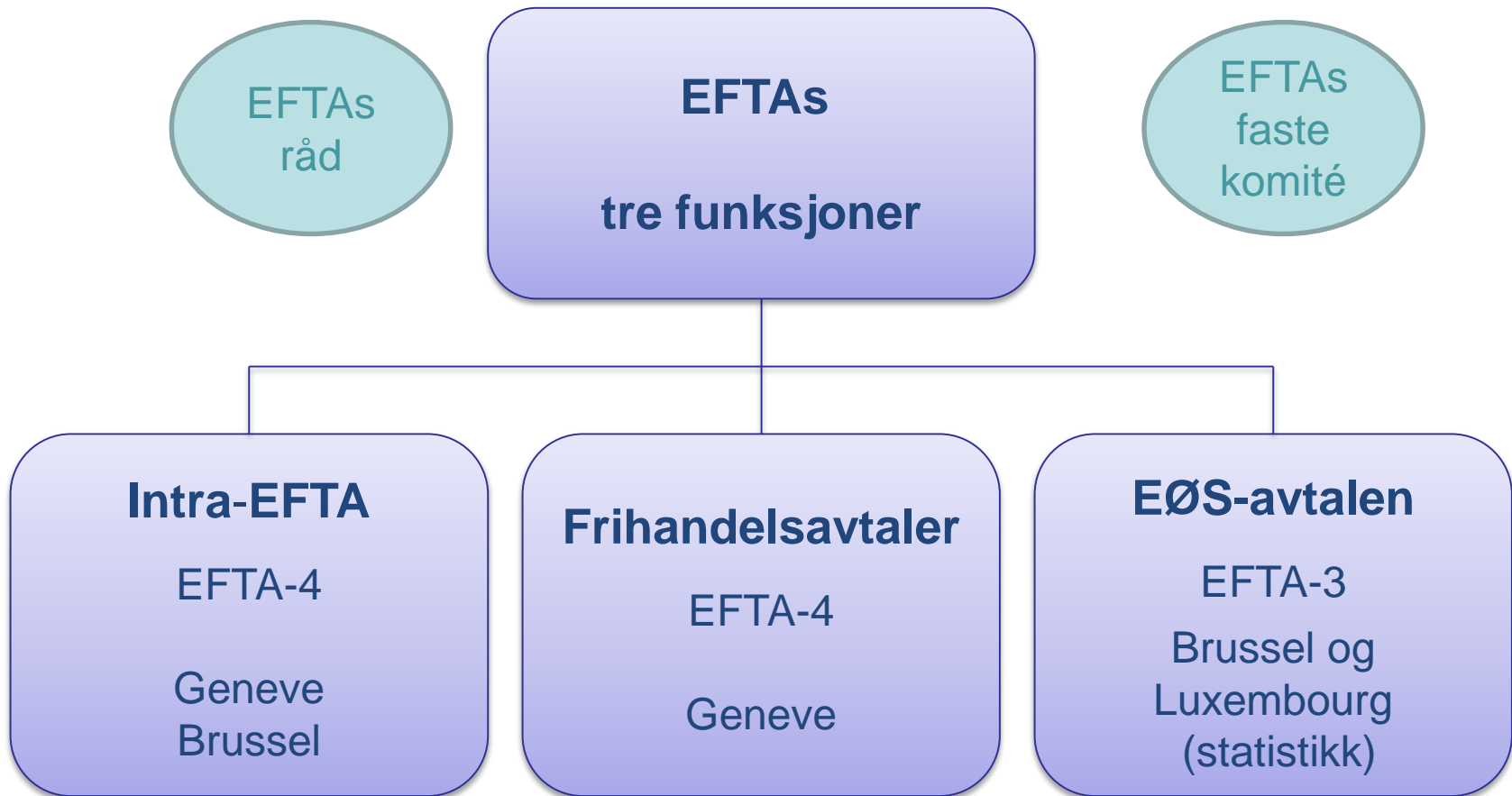

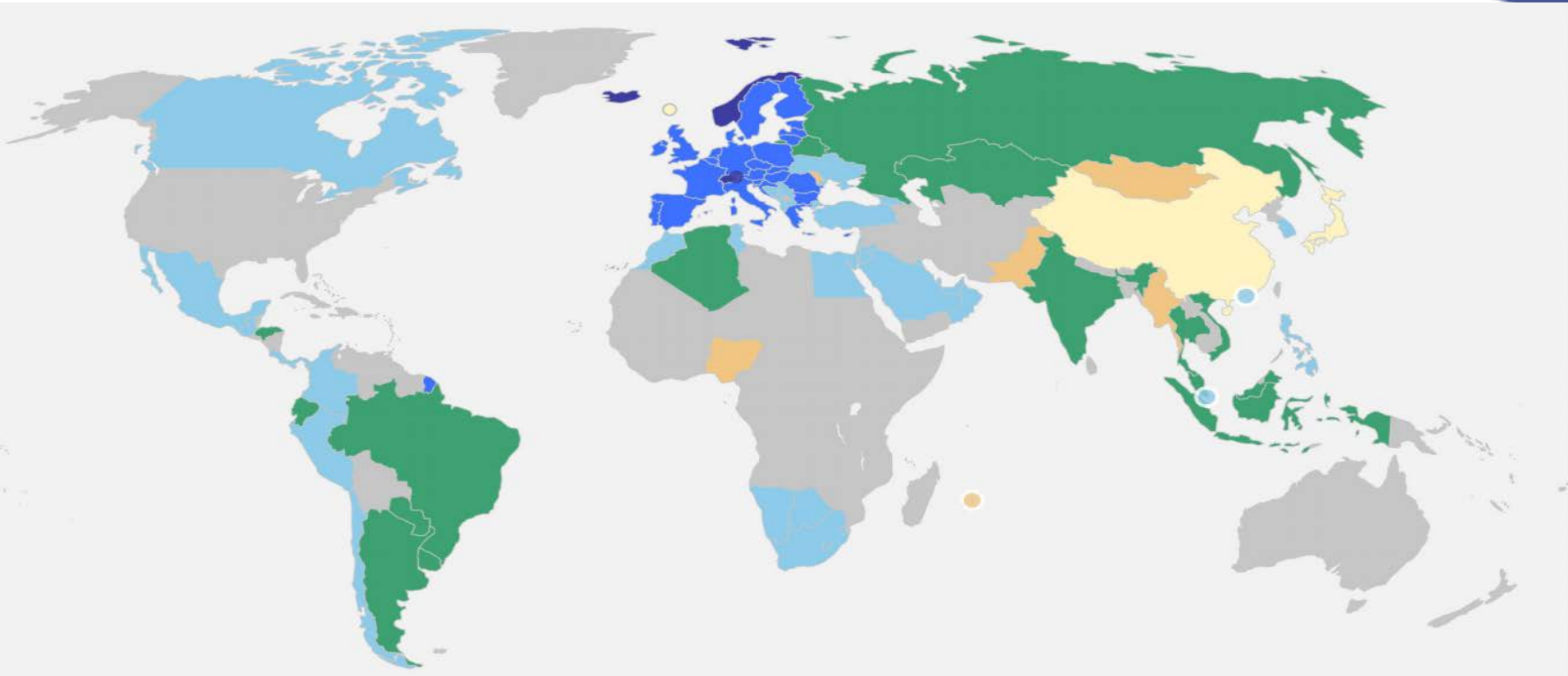


European Free Trade Association (1960)

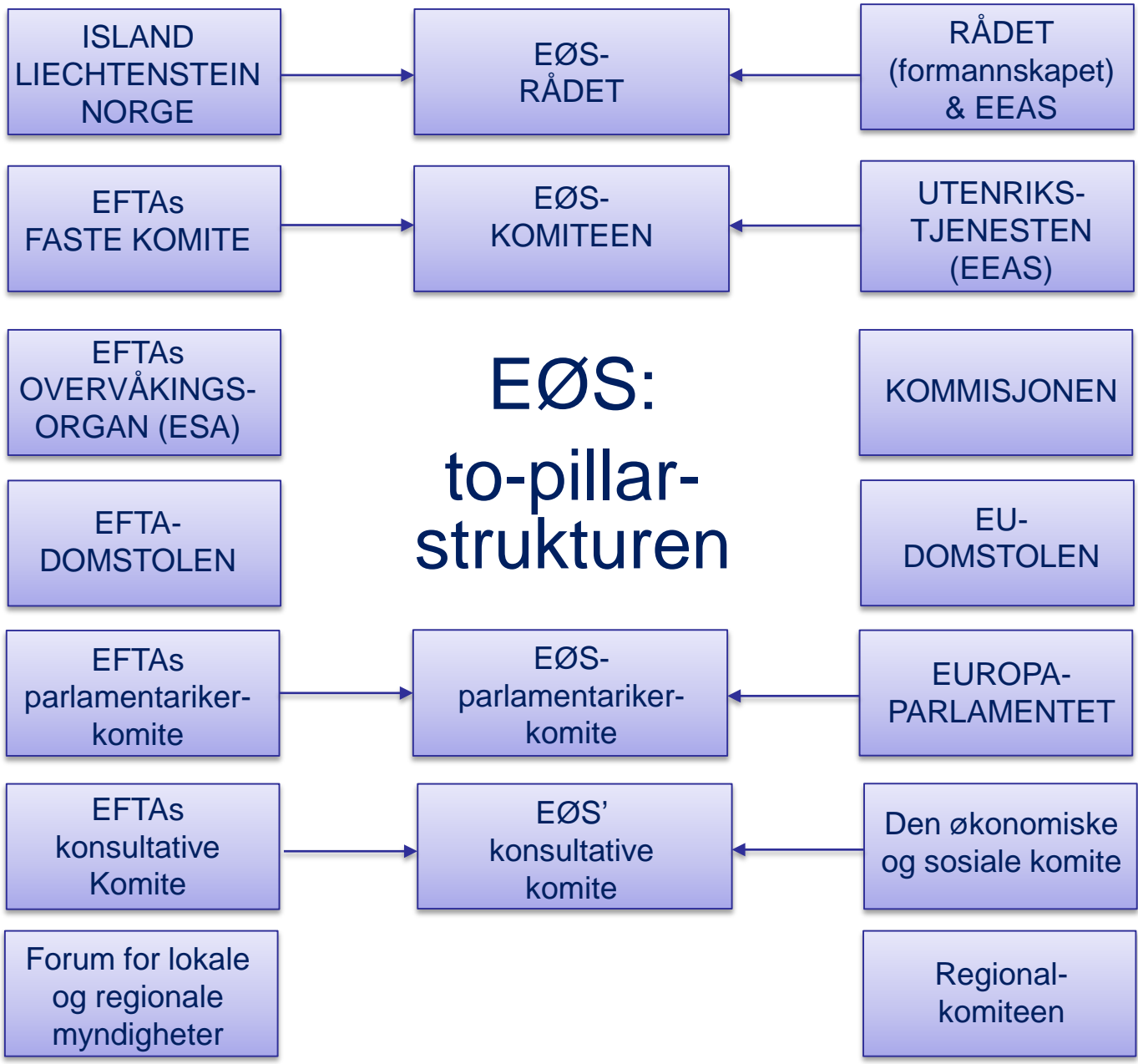

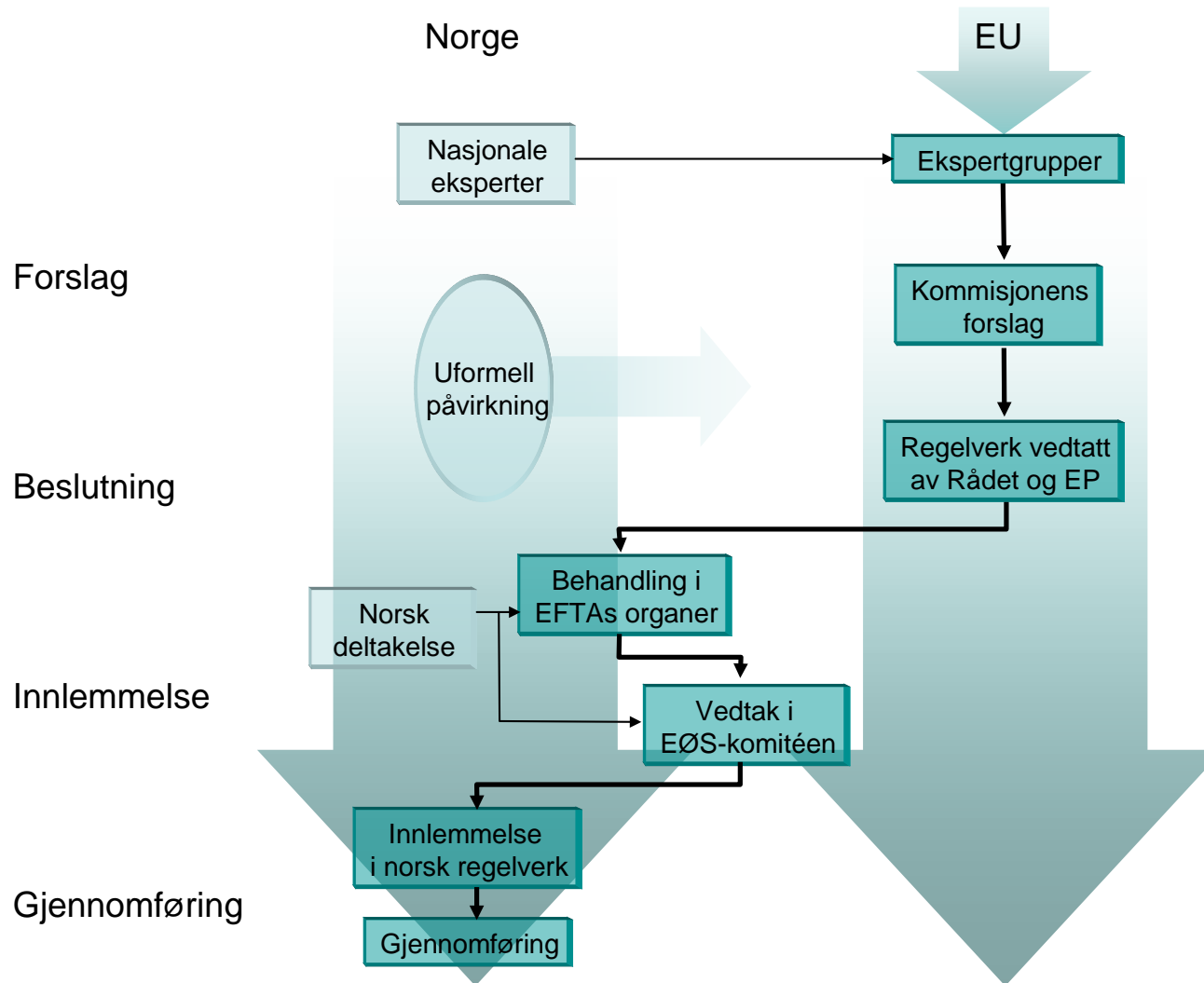

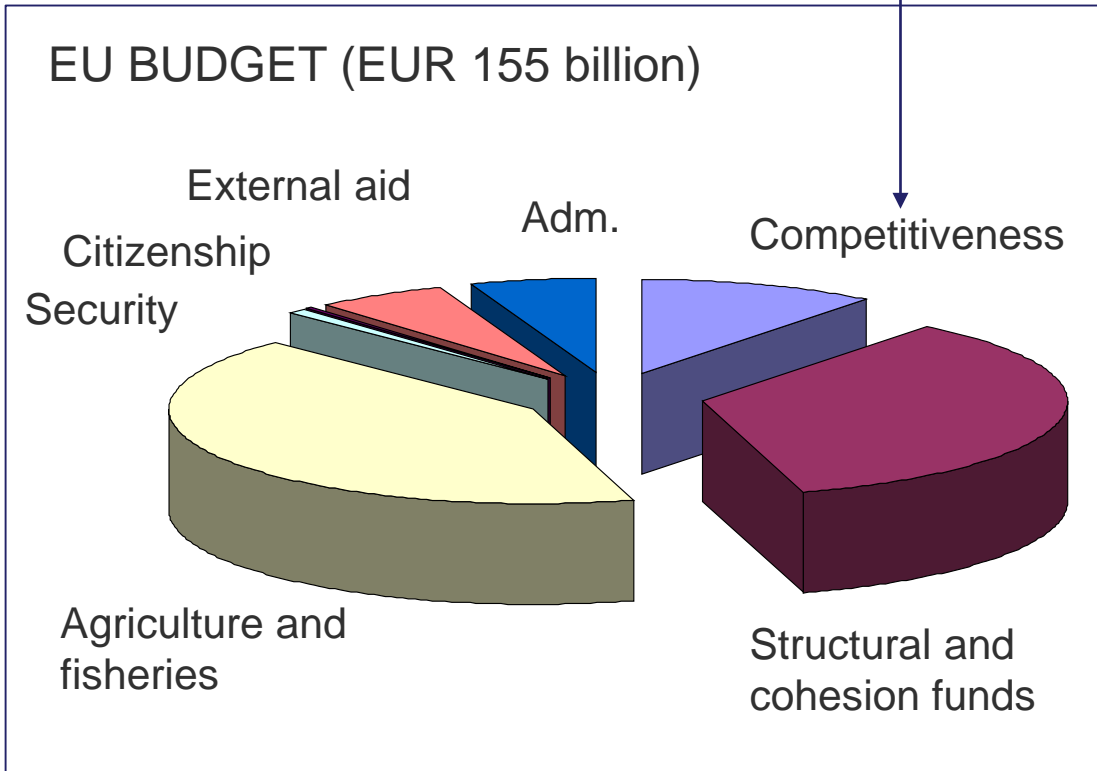


Beslutningsprosessen i EØS

- Deltagelse i EUs programmer og byråer > EUR 450 millioner



- Redusere økonomiske og sosials forskjeller > EUR 400 millioner

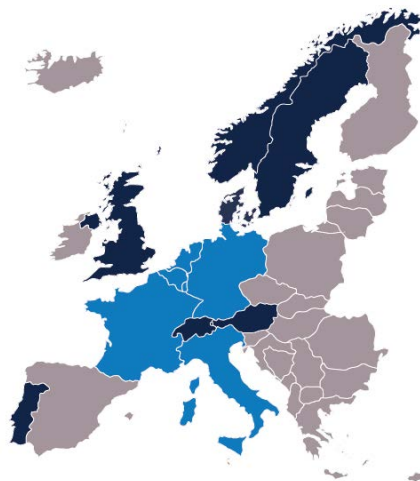


Noen konklusjoner og utfordringer

- EØS-avtalen fungerer godt etter hensikten
- Begrenset formell overføring av suverenitet, men ...
 - Innfører EU-rett uten stemmerett
 - Gjennomføring underlagt uavhengig overvåkingsorgan og domstol
- Kontinuerlig utfordring å forhindre 'etterslep'
- Statisk avtale i møte med EU i endring:
 - EØS-relevans, EU-byråer,
 - Europaparlamentets makt og flere (28) medlemsland
- Økende finansielle bidrag: EØS-midlene og EU programmer
- Manglende kunnskap om EØS-avtalen
- Eksterne utfordringer: Brexit, etc
- Viktigere for EFTA enn EU: Norge har hovedansvar for at EØS-avtalen skal fortsette å fungere
